- **USNG**
 - Publish ArcGIS Pro 1K map project and instructions by end of November.
 - Review and comment on the USNG Center website content.
 - Research ESRI implementation of the "Grid Overlay" widget on Experience Builder, including contacting NAPSOG for coordination with them to further lobby ESRI as necessary.
 - Work with Dakota County and MnGeo to transfer ArcGIS Pro project for creating USNG 10K maps, update maps, and transfer map storage from Dakota County to MnGeo.

 - HSEM could provide evidence of need to MDH if MnGeo needs more support to compel MDH to create a sustainable workflow for keeping up geospatial data.

Most Recent Successes

- During the October 7, 2025 Outreach Committee meeting, the GAC hub build team shared the build of GAC home hub and three committee hubs (Outreach, CAN DO and Data Endorsement) with Megan S and Sally W for their feedback and follow-up with MNIT Communications for an overall branding approval. This will be followed by GAC Executive Team's OK before March 2026 so the build team can proceed with new build for other GAC committee hubs.

Next Activities / Tasks

- Provide a short write-up on GAC's major accomplishments in 2025, to be included in a year-end message in MnGeo Newsletter.
- After the first four ArcGIS Hubs are approved, GAC hub build team will follow the blueprint and move on to build the next four committee hubs.
- With new leadership, Open Data Subcommittee will continue to work on the following.
 - Parcels
 - Encourage counties to contribute more parcel attributes
 - Explore how the Department of Revenue's PRISM data could be used to enhance existing parcel data
 - Alternative methods of assisting counties to extract additional parcel attributes are being explored.
 - Opt-In
 - Continue to contact counties about opt-in
 - A new communications strategy is under development to address remaining counties who are reluctant to opt-in to parcel data. Case studies are sought.
 - Open Data
 - How to address counties concerned with becoming an open data county

Additional Priority Projects and Initiatives Updates

- Statewide Opt-in Composite datasets are available on the MN Geospatial Commons.
 - Of 87 MN counties, 59 contributed parcels, 54 have agreed to contribute address points and emergency service zones, and 53 have agreed to contribute road centerlines to date.

- Parcels, address points, and road centerlines are available for download on the MN Geospatial Commons. The data is being refreshed on a quarterly basis.
 - The open data subcommittee meets every 12 weeks on Tuesdays from 10-11am. Our next meeting is January 7, 2026. Members are asked to report on workgroup tasks between meetings.
- The Outreach Committee convenes at a 6-week interval on a Tuesday from 2-3 PM to monitor GAC Committee Hub sites build progress and the Outreach Committee's community engagement activities and communication endeavors. The first meeting in 2026 will be Jan. 13, 2026.

We want to raise the tax by one point each, generating \$8-10 Million a year for PLSS remonumentation.
